

Instructions for Entries

2024 NMQHA Land Of Enchantment Circuit

1. There are two fee structures available:

A. \$85 Flat Fee per judge. This fee covers all entries for all classes for all exhibitors and all office fees. **Flat fee does not include All-Breed class fees, stall fees, haul-in fees, trail obstacle fee, shavings or AQHA drug fees.**

B. Individual Fee Structure:

AQHA Open, Amateur and Youth Class Fee: \$15 per class per judge

AQHA Open, Amateur and Youth Trail Class Fee: \$15 per class per judge (+ \$10/horse obstacle fee)

AQHA Walk/Trot Class Fee: \$15 per class per judge

AQHA Walk/Trot Trail Class Fee: \$15 per class per judge (+ \$10/horse obstacle fee)

All Breed Open Non-Pro and Walk/Trot Class Fee: \$10 per class (+ \$10/horse trail obstacle fee).

Office Fee: \$5 per horse per judge

AQHA Drug Fee: \$10 per horse, per judge

C. Stall, Shavings and Haul-in Fees (applies in addition to either fee structure A or B above)

All horses must have a stall or pay the daily haul-in fee

Stall Fee: \$25 per night

Tack Stall Fee: \$25 per night

Haul-in Fee: \$20 per horse, per day

RV Spots: \$40 per night. Please note:

If you are parked on the fairgrounds and spend the night in your trailer, you will be charged for an RV spot *even if you do not hook up (\$30/night)*. This is an EXPO New Mexico policy.

2. A signed complete entry form for each horse must be submitted, preferably by email. It is not necessary to send copies of registration papers and membership cards with the entry form, although it is preferred. You must bring the papers and the cards to the show for inspection.

3. If stalls are needed, please send a completed stall reservation form along with the entry forms.

Please make sure to complete the form noting requested stall location preferences, **arrival date** and **departure date**. All stalls and tack stalls will be charged at **\$25 per night**. Tack stalls can be split in between multiple responsible parties. It must be **clearly** marked on all the stall reservation forms as to who is sharing the tack stall and how the fee is being split.

3a. **The 4-W feed store at EXPO New Mexico closes at 3 PM and it is not open on Thursdays at all.** Our move-in days are Wednesday 4/3 and Thursday 4/4. There isn't anything we can do about their hours because it is an independent contractor entity. The numbers to order bedding or feed are 505-934-2681 or 505-259-5341. Once you have your stall assignments, call ahead to order bedding by Wednesday AM, April 3rd, at the latest.

4. Exhibitors who wish to will be allowed to haul-in just for the day. There is a **\$20 per horse per day** haul-in fee. If you are planning on hauling in and using a day stall, please fill out the stall reservation form and submit it with your entries. If you are planning on hauling-in and not using a stall at all, you do not have to fill out a stall form.

5. If the exhibitor has a number that they would like to use, please note that number at the top of the entry form. The number must be four digits or less and the exhibitor will be required to provide the actual numbers. The exhibitor will still be required to check in with the office prior to the start of the show. If the exhibitor chooses to have the show office issue their number, the number will be randomly chosen and will be provided by the show office.

6. Exhibitors/Responsible Parties will be able to pick up their numbers at the show office beginning at 12:00 noon on Thursday, April 4, 2024. If an exhibitor is not checked-in, it will be noted on the gate and announcer sheets.
7. Level 1 classes are classes that were formerly known as Novice and Green.
8. All Breed classes are single judged.
9. All awards must be picked up at the show.
