(Optional) Pre entries close on Wed. the week before the fun show. Please email **form with classes circled** to Kathy@liverytraining.com You must leave open check in office.

Be sure office and paddock know about your scratches and adds for classes.

Buckles given in these divisions: W/T Youth, W/T Open, Novice, Youth and Open (Points kept on one horse/rider combo)

Crossovers allowed from W/T into lope/canter classes, however, **if you show in ANY canter/lope class, other than fun classes, you will NOT be eligible for the W/T Series Buckle Hi Pt.**

Fun classes do not count for any Buckle Series HiPt. You will NOT be penalized for canter/lope in a fun class.

W/T: Any age horse or rider

Classes that count toward W/T YOUTH BUCKLE are: 2 or 3,4,8,13,19,25,31,37,48,53

Classes that count toward W/T OPEN BUCKLE are: 2 or 3,5,9,14,20,26,32,38,49,54

Novice: Any horse or rider that is inexperienced and/or new to showing

Classes that count toward NOVICE BUCKLE are: 2 or 3,4 or 5,10,15,21,27,33,39,42,45,50,55

Youth: Anyone 18 and under from Jan. 1, 2024

Classes that are eligible for YOUTH BUCKLE are: 2 or 3,4,11,16,22,28,34,40,43,46,51,56

Open: Any age horse or rider at any experience level

Classes that are eligible for OPEN Buckle are: 2 or 3,5,12,17,23,29,35,41,44,47,52,57

For safety, please walk your horses in the Parking Areas

No Stallions shown or handled by youth

Boots and a hat and long sleeve shirt and pants will be required to show. Helmets are encouraged for youth.

English or western attire/tack allowed in all classes

Please pick up all hay and manure and deposit in dumpster or take it home. We would like to leave the facility clean and tidy

2 minute gate call will be enforced

Judges decisions are final. AQHA rules will prevail if not covered in the show rules.
